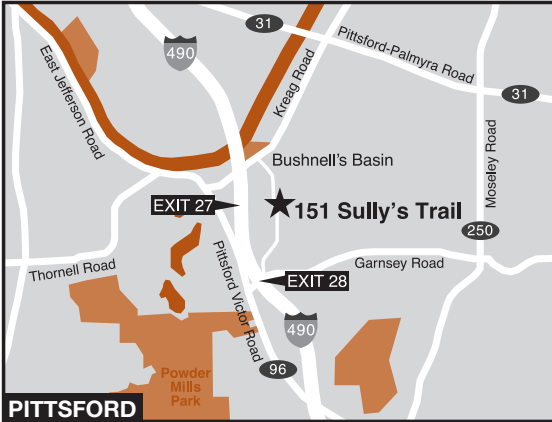

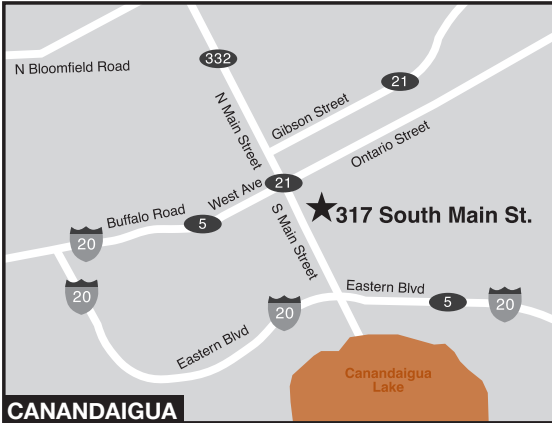
**PITTSFORD OFFICE:**
